



#### Ken Hoyle – Property Grant Application

- b) The Foundation requires appropriate recognition of the Foundation's support and with Property Grants this takes the form of a plaque which is affixed to the property in a place that is visible to the public. Could you please let us know that if you would agree to this form of recognition, if your grant application is successful? (All costs are borne by the Foundation).
  Yes, but the City is concerned the plaque may clutter the building. The WRHF may need to get approval from MHAC for this.
- c) A second quotation is a required element, so we would need one before taking your application forward to the Foundation. In rare cases, a second quote simply isn't possible. For example, we recently funded an application by the Archives in the Dana Porter Library (University of Waterloo) to translate and transcribe letters written in old German by a member of one of Kitchener's founding industrialist families. Academics specializing in this type of work are few and far between, but the Library was able to find someone in Kingston who had the appropriate qualifications. In this case, we waived the requirement for a second quote. With regard to your eavestroughs, we will need a second quote or a written explanation as to why a second quote simply isn't possible.

As discussed, I have been looking for a contractor to do this work for over 10 years. MKM Roofing is the first I have found. They have been very cooperative and continue to show interest and I believe their quote is reasonable considering the work. I intend on painting the facia myself once it is in place before the new eavetroughs are installed.

#### 1. What is the purpose of the project?

Life in the Poorhouse: A Case Study of the Waterloo County House of Industry and Refuge

The project is a research project that intends to uncover a piece of forgotten history in Waterloo Region through a case study of the Waterloo County House of Industry and Refuge. The case study will examine the establishment, governance, procedures and practices of the poorhouse and seeks to reveal the experiences and perspectives of residents, staff and community leaders. The study will collect and analyse currently dispersed information (archival information, newspapers, books) so that community residents and others interested in the topic have access to a piece of Waterloo Region's history that has been to date, largely untold. As we are located in the Faculty of Social Work at Wilfrid Laurier University, we will also explore how today's current ways of helping in a social work context are shaped by the past.



Quote from WM Jaffrey (1871):

"We come upon the Potter's Field, and side by side, rest the forgotten poor who have died in the House, without a single word to mark name, age or anything else connected with the dead, "that Christian ought to know to his soul's comfort." Perhaps, however, this will be rectified in time, and a decent fence put round the burial ground. It is but fair to presume that a county which has done so much for its living poor will not entirely overlook the dead ones—when there is time think over them, and a little more money to expend" (p. 40)

In 1869, Waterloo Township (pop. 7984) became among the first communities in Canada to admit an "inmate" to a newly built poorhouse, called the Waterloo County House of Industry and Refuge. As, quoted above, WM Jaffray, a local lawyer and community leader, toured the poorhouse in 1871 and notes the absence of grave markers for its inhabitants; his observations are an accurate foretelling of how the poorhouse and its inhabitants have mostly faded from the collective memory of Canadians. To date, no one has pulled together local House of Refuge information or analysed and wrote about the House.

Today, many Canadians probably think of the "poorhouse" as an abstract notion, and some may recall their parents or grandparents remarking: "we are going to end up in the poorhouse!" Few recognize that poorhouses physically existed as social institutions, and in the case of Waterloo Region, the House of Refuge hosted residents for almost a century (1869-1951). Poorhouses can be described as a "one stop shop" for people without other means of shelter, food or support. The poorhouse or "poor farm" or in Canada, "houses of industry and/or refuge" offered food and residence for time spent working on the farm that was established alongside the main building.

Studies of poorhouses in North America reveal that inmates, as they were referred to, found themselves at the door of the poorhouses as a last resort, when relatives and friends were unable or unavailable to support each other. There was a wide range of people that sought refuge at the poorhouse including: the elderly, people with disabilities, people with mental illness, people with addictions, widows with children, orphans, the unemployed, young mothers, and others with no other options. The early to mid-19th century was industrializing, the economy was volatile and the notion of a social safety net was decades away. The rise of wage labour, mechanization, the seasonality of work, low wages (especially for women), wretched working conditions, poor medical care, an influx of unskilled and often sick European immigrants, and unsanitary city life set conditions for a growing number of homeless and destitute. The poorhouse was seen as a means to deal with the poor that were beginning to plague the cities.

This project objectives include:

- Completing a case study analysis of the Waterloo County House of Industry and Refuge
- Reveal the history behind the development, governance, policies and practices running the House of Refuge from the early 1860s to 1951
- Uncover the perspectives and experiences of people that lived in the House of Refuge
- Document and analyse the perspectives and experiences of community leader and staff of the House



- Digitalize and analyze the logs (referred to as the Register of Paupers, Vagrants and Idiots received at the House of Industry and Refuge), including an analysis of the demography of inhabitants
- Produce knowledge that contributes to local community history and to current social work and social policy knowledge and practice
- Pay tribute and memorialize the thousands of inhabitants of the House of Refuge

The full cost of this 2 year project is detailed in the attached budget at about 140,000. We are requesting 15,000 in support from the Waterloo Regional Heritage Foundation to support:

- 1. The cost of a transcriber to digitalize the archival information: transcribe the inmate logs and transcribe the meeting minutes.
- 2. The cost of designing a website to share project results publically.
- 2. What is the purpose or significance of this project as it relates to the preservation of heritage within the Region?

This project will be the first time that documents and photos related to the Waterloo County House of Industry and Refuge will be compiled, analyzed and shared with the public (Personal Communication with Region of Waterloo Archivist, August 2013). There were thousands of local community members that once resided in the House. Their experiences deserve a place in local history beyond a paragraph in a history book. This project will bring to light a piece of local history that few people are aware of. The project will document a time and place in local history that has been mostly overlooked.

The local community will benefit from learning about a forgotten aspect of local history and the project will provide insights into how people have responded to citizens in need of help over time in our community. Students and academics will also benefit from the knowledge gained from this project through insights into how the past has influenced the current social policy and social work practice.

Another important aspect of this project is preservation of information in archival documents. A recent report in University Affairs Magazine (August, 2013) underlines the importance of digital archiving. The report discusses the Lac-Megantic Quebec library archives that were lost due to fire in the tragic train derailment explosion. With the support of the Foundation, this project will assist the archivists in scanning archival documents (the resident logs and meeting minutes) and transcribing the information. This will allow for the creation of a new digital resource that will compile a community historical and genealogical resource that is currently only available in analog.

And finally, an important contribution of this project will be to attempt to collect and share the experiences and stories of House of Refuge residents. They were buried in unmarked graves and forgotten. This project intends to shed light on their experiences and honour the memories of the men, women and children who lived in the House of Refuge.

The results of this project will be shared online, through public and academic presentations, and in book form.



3.(a) What is the purpose or mission of your organization?

The Social Innovation Research Group (SIRG) is located in the Faculty of Social Work at Wilfrid Laurier University. The mission of SIRG is to pursue social justice through research and education. SIRG represents a crossroads of academic and community stakeholders who believe and honour the idea that universities should be of service to the communities in which they operate and value mutuality in working partnerships, social innovation and social justice.

SIRG is a research and popular education training incubator which contributes to both the broader community and the academic community in a variety of ways:

University-Community-Collaboration. SIRG has partnered with many local community groups, organizations and individuals to host public education events, awareness raising activities, community projects, and community-based research projects. Examples include: events and research in partnership with many of the organizations in the local violence against women sector, funding proposals, events, projects and research with local Aboriginal community members and organizations, and events and projects with many members of local immigrant and refugee communities and organizations.

Student training. A key contribution for SIRG is that it is a training portal whereby M.S.W. and Ph.D. students are encouraged to develop research skills in collaboration with community partners (funding proposals, process and outcome evaluations, needs assessments, etc.). SIRG offers an educational arena whereby faculty, students and community partners engage in community-based research projects designed to meet the needs of community partners and individuals who seek our support and networks to enhance their own community capacity building strategies

# Waterloo Regional Heritage Foundation Allocations and Finance Committee Report February 25, 2014

1. Application: Ken Hoyle

#### **Summary:**

The Allocations and Finance Committee has reviewed an application from Mr. Ken Hoyle to replace rusting eaves troughs on the east side of his heritage property in Galt, and to add new eaves troughs on the west side to match the front. Mr. Hoyle has requested \$2,500 towards this restoration project.

#### Recommendation:

That the Waterloo Regional Heritage Foundation approve a grant to Mr. Hoyle equal to 50% of the project cost to a maximum of \$2,250 plus HST to replace and add replica eaves troughs to his heritage property at 30 Colborne St, Cambridge; and,

And that the restoration is completed before February 25, 2015, a one-year period from the date of the approved motion;

And that a suitable acknowledgement of the Foundation's contribution is made with the installation of a plaque at the Foundation's expense on the exterior of the building, visible to the public, at a location to be decided by the Foundation and Mr. Hoyle;

And further that a statement of account with copies of supporting invoices and receipts be submitted to the Foundation upon completion of the project with request for payment.

#### Report:

Mr. Hoyle's property is designated under Part IV of the Ontario Heritage Act, and his application has been supported by both the Planning Services Department of the City of Cambridge and Heritage Cambridge.

In accordance with the Foundation's Grant Policies, the applicant submitted two quotations for the replacement eaves troughs. Mr. Hoyle experienced difficulty in finding companies that could make replica eaves troughs, but was able to secure a quote of \$4,500 from MKM Roofing Ltd and a quote of \$8,400 from Robertson Restoration. Mr. Hoyle prefers to work with MKM, and he will prime and paint the new fascia himself, and the eaves trough next year after it has weathered.

## 2. Application: Social Innovation Research Group, Faculty of Social Work, Wilfrid Laurier University

#### **Summary:**

The Allocations and Finance Committee has reviewed an application from the Social Innovation Group to conduct a research project on the Waterloo County House of Industry and Refuge. The case study will examine the establishment, governance, procedures and practices of the poorhouse and will seek to reveal the experiences and perspectives of residents, staff and community leaders. The applicant seeks \$15,000 in support of two elements of the project: (1) to hire a transcriber who will digitize the inmate logs and the meeting minutes; and (2) to design a website which will share project results publically.

#### Recommendation:

That the Waterloo Regional Heritage Foundation approve a grant to the Social Innovation Research Group, Faculty of Social Work, Wilfrid Laurier University in the amount of \$15,000 to hire a transcriber to digitize archival material from the Waterloo County House of Industry and Refuge and to design a website to share project results publically; and,

And that the project is completed before December 2016;

And that a suitable acknowledgement of the Foundation's contribution is made using the official name Waterloo Regional Heritage Foundation and the Foundation's logo;

And further that a statement of account with copies of supporting invoices and receipts be submitted to the Foundation upon completion of the project with request for payment.

#### Report:

The research project being undertaken by the Social Innovation Group (SIRG) is quite large in scope with a budget of \$169,800 in cash expenses with an estimated finish date of December 2016. In addition to seeking \$15,000 from the Foundation, SIRG is applying for two SSHRC (Social Sciences and Humanities Research Council) grants totalling \$155,000. The Faculty of Social Work will contribute \$39,000 in in-kind expenses.

According to the WRHF's Grant Policies, projects must be completed within one year of the grant being approved, but the Policies also allow the Foundation to amend the deadline in special cases. Given the scale of this project, Allocations and Finance

seeks the Foundation's support in extending the deadline to December 2016, the estimated finish date of the project.

#### 3. Application: Conservation Halton Foundation

#### **Summary:**

The Allocations and Finance Committee has reviewed an application from the Conservation Halton Foundation for \$2,000 to contribute to the building of an Iroquoian longhouse in Crawford Lake. The Crawford Lake Hawk Clan Longhouse Project intends to preserve and promote the cultural heritage of an Iroquoian community that resided on Crawford Lake in the 15<sup>th</sup> century.

#### Recommendation:

That the Waterloo Region Heritage Foundation not approve the application by the Conservation Halton Foundation because the building is not located in Waterloo Region.

#### Report:

While Allocations and Finance is supportive of this project in principle, it is unable to recommend approval of a grant because the longhouse is being constructed in another part of the province. According the Foundation's Grant Policies, capital projects must be located in Waterloo Region.
