Declarations of Conflict of Interest

- B. Paddock declared a conflict with respect to item 5 a) iv) on the agenda due to him owning the property.

Accounts and Grant Summary

a) Draft Financial Statements 2014

Connie Bogusat, Financial Analyst circulated the Accounts and Grant Summary, which included a summary of disbursements for April 2015 period, outstanding approved commitments and the Foundation's net funding position.

Delegations

- a) David Seton re: 41-45 King Street W., Kitchener did not appear as a delegation.
- b) Jeremy Smith & Meg Crawford regarding 23 Roland Street, Kitchener appeared before the Foundation highlighting their project. M. Crawford showed various pictures of their property highlighting the work that will be done such as replacement of some bricks, extensive re-pointing and the reconstruction around 2 windows.
- M. Crawford responded to Foundations' questions regarding when the house was built and the two quotes she received.
- c) Karen Ball-Pyatt and Ann Wood regarding KPL Application appeared before the Foundation to highlight their project grant to purchase a book scanner for digitalization project. K. Ball-Pyatt provided a presentation that highlighted the features and capabilities of the scanner, where the scanner will be located and who will be able to access the scanner and the projects they will use the scanner for.
- K. Ball-Pyatt responded to Foundations' questions regarding training and other partners involved in the project.
- d) Bradley Paddock regarding Grant Request Extension appeared before the Foundation and read the letter he submitted requesting a grant extension. He highlighted the challenges finding the right product and how he will proceed with finishing the project.
- B. Paddock responded to Foundations' questions regarding the consideration of using other materials and his next steps.
- e) Robyn Huether, Architect appeared before the Foundation regarding Omar Kaake's grant application for his property located at 2 Water Street, Cambridge. She provided an update on the project and some challenges they have run into. She provided a presentation highlighting the work that has been done on the property and where the precast units are needed since they no longer can get the terracotta.

R. Huether responded to questions regarding other options considered and highlighted that only 1% of the building will need precast units.

- a) Allocations and Finance Committee
 - Property Grant Application: 41-45 King St. W. Kitchener
- S. Massel provided background information on the application noting they received the application in March but that there were numerous items missing from the application. She stated that B. Paddock worked with the applicant until all the missing documents were received. S. Massel highlighted that while watching the City of Kitchener's Council meeting on May 11th the applicant addressed Council and referenced that 41-45 King Street W. property was completed. S. Massel stated that they received confirmation from David Seton that in fact the project was completed and that D. Seton was informed that the grant policies of the Foundation state that completed projects are not entitled to receive funding. S. Massel read an email submitted by D. Seton indicating that he is withdrawing his application.

That the Waterloo Regional Heritage Foundation approve a grant equal of 50% of the net cost to a maximum of \$7,992.00 including HST for brick replacement and re-pointing work on 23 Roland St, Kitchener;

And that a suitable acknowledgement of the Foundation's contribution is made with the installation of a plaque at the Foundation's expense on the exterior of the building, visible to the public, at a location to be decided by the Foundation and the applicants;

And further that a statement of account with copies of supporting invoices and receipts be submitted to the Foundation upon completion of the project with request for payment.
