Election of Chair and Vice Chair

Erin Flewwelling called the meeting to order and called for nominations for the position of Chair and Vice-Chair for a one-year renewable term from June 2016 to June 2017.

Accounts and Grant Summary

Erin Flewwelling circulated the Accounts and Grant Summary on behalf of Connie Bogusat, Financial Analyst, which included a summary of disbursements for June 2016 period, outstanding approved commitments and the Foundation's net funding position.

Delegations

- a) Jody Ball appeared before the Foundation regarding the property grant for 38 Lansdowne Road N. Cambridge. He showed a presentation that highlighted the property. He stated that he purchased the property in June 2015 as a triplex and the intention is to convert it back to a single family home. He provided clarification on the windows and Juliet doors.
- b) Cory de Villiers appeared before the Foundation regarding the property grant for the Old Hespeler Hotel located at 39 Queen St, E. Cambridge. He provided a presentation that highlighted the property. He stated that this is the second time he is appearing before the Foundation for a grant request. The first request was made in 2009. He provided clarification on moving the AC units.
- c) Philippe Elsworthy appeared before the Foundation regarding a publication grant: Evolving Urban Landscapes. He showed pictures of architecture around the Waterloo Region from his book.

Susan Burke appeared in support of Philippe Elsworthy and provided background information and highlighted P. Elsworthy expertise.

A Foundation member asked for clarification on the printing costs. P. Elsworthy noted that he included the HST in the final cost and he highlighted where the book will be sold.

d) Stephen Litt appeared before the Foundation regarding the property grant for Windermere Apartments located at 48 Weber Street W. He provided a detailed presentation that highlighted all the renovations at the Windermere Apartment building.

2016-2017 Committees

- a) Allocations and Finance Committee
 - i. Property Grant: 38 Lansdowne Road N. Cambridge

Members discussed replacement verses restoration and what the end project was going to look like. It was noted that the house is designated and needs to be within the guidelines of the City and the City is satisfied with the applicant's proposal.

That the Waterloo Regional Heritage Foundation approve a grant of 50% of the cost to a maximum of \$62,672 including HST for replacement of windows and doors at 38 Lansdowne Road North, Cambridge;

And that a suitable acknowledgement of the Foundation's contribution is made with the installation of a plaque at the Foundation's expense on the exterior of the building, visible to the public, at a location to be decided by the Foundation and the applicants;

And further that a statement of account with copies of supporting invoices and receipts be submitted to the Foundation upon completion of the project with request for payment.

ii. Property Grant: Hespeler Hotel 39 Queen St, E.

That the Waterloo Regional Heritage Foundation approve a grant of 50% of the cost to restore the doors to historically accurate stable doors to a maximum of \$2,738.00 including HST for the Old Hespeler Hotel located at 39 Queen Street East, Cambridge;

And the restoration is completed before June 28th, 2017, a one-year period from the date of the approved grant;

And that a suitable acknowledgement of the Foundation's contribution is made with the installation of a plaque at the Foundation's expense on the exterior of the building, visible to the public, at a location to be decided by the Foundation and the applicants;

And further that a statement of account with copies of supporting invoices and receipts be submitted to the Foundation upon completion of the project with request for payment.

iii. Publication Grant: Evolving Urban Landscapes

That the Waterloo Regional Heritage Foundation approve a grant to Philippe Elsworthy in the amount of \$6,000 for the purpose of publishing "Evolving Urban Landscapes" as described in the application for grant funding;

And that the Foundation's official name and logo appear in the publication recognizing he contribution made by the Foundation;

And that a copy of the publication be given to the Foundation;

And further that a statement of account with copies of supporting invoices and receipts be submitted to the Foundation upon completion of the project with request for payment.

- iv. Property Grant: Windermere Apartments 48 Weber Street W.
- S. Massel highlighted that the property falls under the Heritage Conservation District bylaw which requires additional information and that the application still needs a letter of support. She indicated that A&F is not prepared to put forward a recommendation until the additional documents have been received. It was also suggested that a tour of the property be arranged.
 - v. Katy Belshaw Project/Event Grant
- S. Massel highlighted that A&F is recommending not to move forward with the application since the applicant is asking for funding to purchase equipment and to pay salaries.

That the Waterloo Regional Heritage Foundation not move forward with a grant to Katy Belshaw for the project P.S.: Place in Space as the grant is requesting to purchase equipment to develop a software platform and to pay salaries for development time and has no historical content for this portion of the project.
