DECLARATIONS OF CONFLICT OF INTEREST

Chair S. Rung declared a conflict of interest with regard to item 2(a), publication grant application, owing to her consultation on the project.

DELEGATIONS

- a) Susan Saunders Mavor re: publication grant application
- S. Mavor provided an overview of the proposed work outlined in the application, including:
 - Overview of the history of the Westmount neighbourhood;
 - Her experience growing up in the neighbourhood, and being introduced to archival materials related to the neighbourhood;
 - Work on Westmount history initiated five years ago;
 - Publication of a Westmount history article in a past annual volume of the Waterloo Historical Society, and noting student research on the neighbourhood;
 - New primary sources discovered via descendents of families from the neighbourhood;
 - Solicitation of primary source material from current residents via flyer circulated to Westmount Neighbourhood Association;
 - Hiring of freelance title searcher to verify land transactions and age of neighbourhood;
 - Project receiving support via University of Waterloo Library, anticipate applying for funding from the Kitchener and Waterloo Community Foundation;
 - Additional quotes for proposed work are anticipated to be received in the near term; and
 - Display and circulation of mounted photos and newspaper articles related to the neighbourhood.

She indicated that certain vendors would be preferred, given their history of quality and the expertise available on their staff.
