

1. Call to Order

Chair D. Emberly called the meeting to order at 5:30 p.m.

2. Land Acknowledgement

J. Hale, Foundation Secretary, provided a land acknowledgement.

3. Declarations of Conflict of Interest

None declared.

4. Award Presentation

Chair D. Emberly provided an overview of the history of the Foundation Awards of Excellence including previous award recipients. He noted that the Award of Excellence has not been granted since 2018.

N. Baskanderi spoke to the achievements of the award recipient, Juanita Metzger. Her achievements include neighbourhood community development and Stroll Walking Tours which began in 2019. Stroll Walking Tours showcases stories that have been untold, dismissed or forgotten and demonstrates the connection between history and the Region of Waterloo today. By creating an awareness about diversity history and other communities, perspectives are shifted and some common understandings are challenged.

The Foundation presented the award to J. Metzger.

J. Metzger accepted the Award of Excellence and thanked Senta Ross for nominating her for this award. She further thanked the Foundation for the award and for funding her heritage walking tours. She highlighted that the walking tours she leads are creative and people focused, specifically, in illustrating the accomplishments of women throughout history. In response to the Foundation, she confirmed that her walking tours have be utilized by the Board of Education for both education and artistic purposes.

Regional Chair K. Redman acknowledged the good works of J. Metzger and the importance of continuing to raise voices and continuing a strong sense of community. She recognized how important projects like the walking tours are as the Region of Waterloo continues to grow and how important the work is to promote connectivity of past, present, and future. She suggested that the Regional Townships would also enjoy the walking tours in their Towns.

Responding to the Foundation, J. Metzger explained that the walking tours have not directly worked with the Women's Institutes of Canada, however, in the St. Jacobs walking tour they do feature that local history through the perspective of women.

5. Finance Reports

5.1 Accounts and Grants Summary

D. Emberly provided a brief explanation of the Account and Grants Summary and identified that the grant recipient Capoeira KW/Ruddy Brunherotto dos Santos has withdrawn their project as they could not complete it by the deadline. The Foundation directed staff to adjust the amount being held for distribution on the account summary to remove the grant amount of \$2,880.00.

The Foundation discussed different options for catering and directed staff to order the minimum amount of sandwiches.
