- i) Publication Grant Application Susan Fish Re: St. Jacobs Farmers' Market Cookbook publication

- a) Architectural Conservancy of Ontario, N-W Branch
- P. Clarke gave a verbal update on the recent events of N-W Branch, Architectural Conservancy of Ontario. The organization attended the Waterloo Regional Archivists Interest Group Meeting; Climate Action Workshop; and held a focus session at St. John's Kitchen.

They are organizing a "Celebration of Rockway History" event on May 15 and is hosting a local building tour on May 24 of such sites such as Breithaupt Block.

They have been completing a membership survey online, to get more in touch with ACO members locally and determine where people's priorities are.

- b) Heritage Cambridge
- B. Paddock gave a verbal update noting they are 18 days away from The Annual House Tour that will feature historic homes and properties in Hespeler and the Black Bridge area.

He provided background information on a farm house in Preston along the Grand River noting they are currently trying to determine if someone can take the house or at worst case salvage some materials onsite. He expressed concerns with the lack of consideration for salvaging materials and suggested that perhaps there should be a policy in the City of Cambridge.

- J. Glass provided a verbal update on the Waterloo Historical Society noting the next public meeting will be on May 11th, and Dr. John Carter will be speaking on The Canadian Rebellion of 1837-1838 and what effect, if any, on the area. J. Glass highlighted that they will handing out their 100th Anniversary Volume at that meeting. He also noted on May 18th at 11:00 a.m. they will be having their 100th annual plaque unveiling at the Waterloo Regional Museum and Warren Stauch will be making a presentation.
- J. Glass advised that the next Waterloo Historical Society public meeting will be their Annual History Under the Trees meeting on July 6th.

- D. Bonk provided a verbal update highlighting the Society's summer plans to finish the Township of Wilmot's cemeteries. He highlighted that there will be a guest speaker at the next Ontario Genealogical Society meeting.

To: The members of The Waterloo Regional Heritage Foundation:

A year ago, The Waterloo Regional Heritage Foundation authorized a grant for the recording and student-accessible website design of a "Heritage Song Cycle" named "The River Rolls." The request came to you from the three composers — Charlene Nafziger, Mike Erb and myself, Paul Knowles. "The River Rolls" is a musical presentation that tells the stories of Waterloo Region in song and narrative links.

Our intention was to complete the project within 12 months. However, some personal issues in the summer of 2012 delayed the recording for several months. We did resume the project in 2012, however, and we are now at this point:

The professional recording of all 14 songs and 14 narrative links is completed, carried out at CedarTree Recording Studio, using eight musicians and performers.

The professional mixing of the recording is a few days from completion.

Design of the CD cover is being carried out by artist Diana Erb.

Work has begun on the website, <u>www.theriverrolls.ca</u>

Two public performances of "The River Rolls" have been booked for the fall of 2013, sponsored by area businesses. One will be at the Waterloo Region Museum, Sept. 27; the second at Steinmann Mennonite Church, Oct. 4. Advance notice of these concerts has included credit to the Waterloo Regional Heritage Foundation.

The project will be completed by this Fall – the completed recording, a finalized website with full access to teachers and students in the region. Obviously, we have already incurred the bulk of the expenses covered by the grant from the Heritage Foundation. I write to request an extension from the Foundation, allowing us to complete this project within the current calendar year (although we will be finished well before the end of 2013).
