#### **Accounts and Grant Summary**

- a) Allocations and Finance Committee
- S. Massel provided an update on the grant applications stating A&F will be inviting Rob Ring to attend the January meeting. He has applied for grant requesting funding to make a film about Frank Groff, aka The Bridgeport General. She noted that A&F is still working on The Elmira Project and highlighted that L. Haggerty is working on the KCI project noting a grant was submitted a year ago but it was never completed because of missing information but stated KCI is interested in finishing the project and completing the application.
