Chris and Kim Coghlan appeared before the Foundation in regards to the replacement of their cedar shingled roof noting the estimated cost of \$80,000.00 is not feasible and requested advice on different options.

Report Given on Behalf of the Architectural Conservancy of Ontario Cambridge and North Dumfries Branch.

The ACO appeal to the then Ontario Municipal Board of the development proposal by HIP Developments for the Cambridge Gaslight District (previously called Southworks) was met with approval by the adjudicator whose decision was to allow the appeal to proceed to a full OMB hearing. The appeal was avoided when the two parties entered into Minutes of Settlement by which the ACO agreed to withdraw its appeals to the Local Planning Tribunal (formerly called the OMB) and the developer has agreed to preserve up to three times as much of the original facade and the north building (the site's original front door). Original artifacts and materials are to be dismantled and preserved for future uses. The buildings date from the 1890's and the site is one of the few remaining early Ontario industrial complexes. The site will be designated under the Ontario Heritage Act

The annual general meeting of members will be held on Tuesday, March 26, 2019, at 7:00 p.m. and will take place in the Fashion History Museum, 74 Queen Street East, Cambridge; this building is the former Town of Hespeler post office. The hosts are Jonathan Walford, Curatorial Director, and Kenn Norman, Founding Chairman.

Report of the Waterloo Historical Society.

In February the Society's membership stood at 161 and is expected to rise throughout the year to about 220. The 106th Annual Volume is about to be published and distribution will begin at the May 21, 2019 public meeting at the Victoria Park Pavilion. At the moment there are 50 Benefactors, Patrons and Friends whose generosity make this publication possible; it is expected their number will rise to about seventy by year's end.

The digitising of the Waterloo Chronicle by the Waterloo Public Library progresses and the 1893 material loaned by the WHS has been returned. The Society continues to work on the merging of the individual indices of it's annual volumes, a project that received important funding from the Waterloo Regional Heritage Foundation.

The WHS continues its decades long tradition of presenting lectures informative of the culture and history of Canada with particular emphasis on the Waterloo Region. The next public meeting of the Society will be at the Victoria Park Pavilion, Saturday, April 6, 2019, at 1:00 p.m. The speaker will be Tara Brookfield, a professor of history and youth and children's studies at Wilfrid Laurier University, Brantford Campus. She will be presenting on research conducted for her second book, Our Voices Must Be Heard: Women and the Vote in Ontario (2018) which examines the history of suffrage activism, anti-suffragists, and Ontario's first women voters, including stories of women from what is now the Waterloo Region.
