THAT the Waterloo Regional Heritage Foundation approve the purchase of its 2013 insurance portfolio at an annual premium of \$2,153 plus applicable provincial sales tax of 8% (\$172.24), totaling \$2,325.24 from the ING Halifax Insurance Company (through Cowan Insurance Brokers Ltd.) under the terms and conditions outlined in the Treasurer's Report dated January 22, 2013.

SUMMARY: Nil

REPORT:

The Waterloo Regional Heritage Foundation's insurance portfolio renewed on January 1, 2013 and coverage has been secured subject to the Foundation's approval. The insurance renewal premium on the Foundation's account has increased \$26.00 or 2.4% over last year's premium of \$2,127.

Since last year, insurance market conditions and rates have remained stable. The Foundation continues to enjoy favorable premium rates because of its excellent claims history and limited exposure. Staff has been advised by Cowan Insurance Brokers Ltd. that the Foundation's insurance program was presented to other insurance companies doing business with their brokerage. The response received was that other insurance companies did not underwrite this class of business and for those that did; their premiums were not as low as that offered by the current insurer.

Commentary by Policy Coverage Being "Renewed"

In 2013, the Foundation's insurance portfolio will consist of the following types of coverage:

Comprehensive General Liability: Coverage Limit \$2,000,000

This type of coverage insures the Foundation against liability imposed by a Court of Civil Law for damages because of bodily injury or death to any person resulting from the operations of the Foundation and for damages to/or destruction of property of others caused by an accident.

Directors & Officers Insurance: Coverage Limit \$2,000,000

This form of insurance covers Directors and Officers against liability suits resulting from an action by a third party that alleges failure of the Directors, or Officers to exercise proper care and skill in the managing of the Foundation.

4. What is the purpose or significance of this publication, and how does it contribute to the preservation of heritage within the Region?

The Grand, Speed, Eramosa, Nith and Conestogo Rivers were declared Canadian Heritage Rivers in 1994. The Grand River Conservation Authority spearheaded the designation process on behalf of its member municipalities. The Heritage River Inventory was created prior to the designation to demonstrate why the Grand River and its major tributaries warranted national recognition.

The Heritage River Inventory is updated from time to time as new information becomes available. The inventory is guided by the Cultural Framework for Canadian Heritage Rivers released in 2000 by the Canadian Heritage Rivers Board. The Heritage River Inventory is an



important reference tool for developing annual and decadal monitoring reports which are required by the Canadian Heritage Rivers Board.

Historic bridges are key features supporting the Canadian Heritage River designation. The Heritage River Inventory includes some historic bridges, but not all. The Heritage Resources Centre, in partnership with the Grand River Conservation Authority and the Heritage Working Group, was successful in securing funding to undertake a comprehensive inventory of heritage bridges within the Grand River watershed.

The listing of heritage bridges important to the Canadian Heritage River designation has been determined by the Heritage Resources Centre in consultation with watershed municipalities. A comprehensive bridge inventory will provide a planning tool for municipalities to consult when work associated with a bridge is contemplated. It would:

- identify whether a bridge has heritage significance;
- ensure consistency in the criteria and approach used to evaluate bridges in the Grand River watershed:
- identify whether or not a Heritage Impact Assessment would be required as part of an Environmental Assessment at the beginning of the EA process; and
- provide information that can be incorporated into a municipal cultural plan or heritage master plan.

This information will also be extremely useful to the Grand River Conservation Authority for the preparation of the 20-Year Monitoring Report, due for submission to the Canadian Heritage Rivers Board in 2014.

This report will contribute to the conservation of historic bridges and associated cultural hertiage landscapes by highlighting their signficance and relevance to the overall history of the Grand River watershed. To date, 190 heritage bridges have been identified for inclusion in the inventory. Many of these resources have never been researched and evaluated, as a project of this scope has not been undertaken. For the first time a complete and thorough inventoy of the entire watershed has been completed, capturing the signficance of unique bridge types and trends. It is also serving to highligh an alarming trend in demolition among specific bridge types, such as concrete bowstring arch and steel truss bridges. Each heritage bridge has been evaluated using Ontario Regulation 9/06, a respected evaluation criteria that sets the ground work for designation under the Ontario Heritage Act.

5. List any other financial assistance which has been approved or applied for towards this project(include any matching funds, regular budget allocations, Ministry grants or any other financial assistance for this project).

The HRC revceived funding from the Ministry of Tourism, Culture and Sports' Canadian Communities Prosperity Fund (CCPF) to undertake this heritage bridge inventory project. However, we received much less funding then we had applied for, which has made completing this very large and long-term project a challenge. In our budget we have \$3,500 allocated to printing but no funding for graphic design support. The HRC would like to use \$1,500 to pay an MA student from the School of Planning at the University of Waterloo with graphic design experience to craft a professional and attractive report.



6. Would this be published without a grant from the Foundation? Please explain.

Without additional funding, the quality of the report would appear less professional and perhaps less respected by key stakeholders. The goal of the HRC is to have this report as widely read as possible to increase the conservation efforts related to heritage bridges in the Region, watershed and Province.

7. Provide details on potential market for publication and proposed method of distribution:

The market for this report is large. It would include: each municipality in the Grand River watershed (39 upper and lower tier), Grand River Conservation Authority (GRCA), Heritage Rivers Board, Ministry of Tourism, Culture and Sport (MTCS), Ministry of Transportation (MTO), municipal planning and public works departments, private consulting firms, architects, municipal heritage committeess, tourism industry, educators, property owners and the general public. The reports will be mailed to each watershed municipality, GRCA, MTCS and MTO. The report will also be made available electronically on the HRC and GRCA's websites.

Re: Grand River Watershed Bridge Inventory

The Grand River Watershed Bridge Inventory project undertaken by the Heritage Resources Centre and the Grand River Conservation Authority, to fully inventory the bridges in the entire Grand River Watershed, is an important and timely Cultural Mapping Project. At a time when many historically significant bridge structures are being demolished and replaced, the communities along the Grand River, a Canadian Heritage River, are working to identify and conserve these resources. Heritage Bridges play an important role that goes well beyond their obvious function as connective components of our transportation infrastructure. They contribute to our community's social and economic development and reflect the technology of the times they were built in. Many of these bridges are familiar and distinctive landmarks that contribute to a strong sense of place and link the current generation to the past.

In 2008, over 100 bridges were inventoried and ranked according to their heritage significance in Waterloo Region. This research has lead to more detailed research on the top 10 historically significant bridges as well as on the twelve steel truss bridges that grace the region's waterways. The Region has seen the restoration of 8 of the top 10 bridges and through the Heritage Bridge Recognition Program has been developing interpretive plaques for each bridge and has highlighted significant bridges on historical driving tour brochures.

Through the Grand River Watershed Bridge Inventory project this type of research has been undertaken for the full watershed - linking the communities along the Grand River and resulting in the broad identification of a shared resource that characterizes the watershed. From our experience at the Region of Waterloo we are hopeful that the inventory of these resources will be the foundation to the long term recognition of the importance of these structures to our communities' future growth and development. Now that this research has been completed, we look forward to seeing it published, shared and used in the conservation of these significant heritage resources.

RE: Grand River Watershed Bridge Inventory

In 1987, the Grand River Conservation Authority, on behalf of its member municipalities, spearheaded a participatory process to have the Grand River and its major tributaries declared Canadian Heritage Rivers. This initiative was also supported by several provincial ministries, including the Ministry of Culture. The designation of the Grand River and its major tributaries was put forward by the Province of Ontario through its representative on the Canadian Heritage Rivers Board. This national designation was achieved in 1994, based on outstanding river-related human heritage and recreational features/values of national significance. It gives national recognition to the rivers but carries no regulatory or legal restrictions.

If the human heritage features/values for which the river was designated a Canadian Heritage River are degraded or lost, the river can be de-designated from the Canadian Heritage Rivers System. The loss of one feature/value does not in itself warrant loss of the heritage river status. It is the cumulative effect of the loss of many which would cause the Canadian Heritage Rivers Board to re-evaluate the status of the rivers. The Grand River Conservation Authority, on behalf of its member municipalities, is the agency that reports these changes to the Canadian Heritage Rivers Board.

The Grand River watershed contains a significant array of heritage bridges of different types, materials and construction methods constructed over the past century (see Crossing the Grand by David Cuming, Grand Actions Newsletter, Volume 4, No. 2, 1999). Bridges are a vital component of the watershed's human heritage and tell us much about the history of settlements, changing technology and transportation. They are also distinctive landmarks and community gateways and icons.

However, over the last two decades, many of the heritage bridges in the watershed have deteriorated to a point where they need major repair or replacement. In many instances, municipalities do not have the human, financial, planning and other resources needed to protect their heritage bridges. The fate of each structure is dealt with individually through an Environmental Assessment process undertaken by the municipality or the Province, whichever applies. This process does not take into account the upstream-downstream and cross-boundary heritage links along the river system. Sometimes, heritage impact studies for heritage bridges are overlooked. Consequently, many of the heritage bridges which represent the human heritage elements which contribute to the national designation for the Grand have been lost or are at risk of being lost.





No comprehensive inventory of the number and value of heritage bridges in the watershed exists, although the Region of Waterloo has undertaken a complete inventory of bridges within its municipal boundaries. Access to a complete inventory of heritage bridges within the Grand River watershed would provide a valuable planning tool for all watershed municipalities to strategically assess which bridges are worthy of protection and rehabilitation long before the need to rehabilitate or replace the bridge is contemplated. This would assist municipalities in making strategic decisions about these heritage structures and take the necessary steps to ensure that key heritage bridges are maintained and protected in support of the Canadian Heritage River designation.

For these reasons, the Grand River Conservation Authority strongly supports this proposal as a worthy candidate for CCPF funding and is pleased to be a partner in this proposal. As such, the Grand River Conservation Authority has agreed to provide \$2,000 in funding towards the project as well as \$12,000 worth of services in-kind (\$10,000 consultation and \$2,000 technical support to enter inventory data into the web-based heritage river inventory available through the Grand River Conservation Authority website).



General Description

The Main Street Bridge spans the Grand River between Water and Melville Streets, in the former City of Galt, now the City of Cambridge. The bridge is a multiple-span concrete bowstring arch bridge and was constructed in 1931. The property was designated by the City of Cambridge in 1982 for its heritage value under Part IV of the Ontario Heritage Act (By-law 2225). The Cambridge Main Street Bridge has also been listed on the Ontario Heritage Bridge list, a list of provincially significant bridges maintained by the Ministry of Tourism, Culture and Sport.

Cambridge's Main Street Bridge is located in the historic centre of the former City of Galt and spans the Grand River, a Canadian Heritage River. It is part of a group of four multiple-span concrete bowstring arch bridges spanning the Grand River that were erected in the same time period and in a similar style. These bridges are a part of the upgrading work that took place to the transportation networks in Ontario, after the First World War, to accommodate the increased number of automobiles. This group includes two other bridges within the Region of Waterloo, the Freeport Bridge and the Bridgeport Bridge in Kitchener. The fourth bridge, the Caledonia Bridge is located in the nearby City of Caledonia.

The Cambridge Main Street Bridge crosses the Grand River and connects the east and west sides of downtown Galt, making it the most important bridge in the City of Cambridge. The first bridge on this site was a three-span steel truss bridge built in 1819 and rebuilt 1858. The current bridge was commissioned by the former City of Galt, at a cost of approximately \$55,000. The structure was designed by Archibald B. Crealock, a consulting engineer from Toronto and was built in four months, by W.H. Yates Construction Company Limited of Hamilton. The official opening of the Main Street Bridge took place on December 22, 1931.

The Cambridge Main Street Bridge is a reinforced concrete bowstring arch bridge with decorative concrete rails and balustrades. The bridge's bowstring design was popular in the 1920s and 1930s as it required minimal material, was simple to install and could easily accommodate vehicular traffic. The bridge's abutments and piers are built entirely on limestone bedrock. Two lanes of cars can cross the bridge and 8-foot wide sidewalks, one on either side of the vehicular traffic, allow for safe pedestrian passage.

RECOMMENDATION:

THAT Report No. CW-04-12-44 - Grand River Bridge Inventory be received as information.

SUMMARY:

In 1987, the Grand River Conservation Authority (GRCA) on behalf of its member municipalities, spearheaded a process to have the Grand River and its major tributaries declared Canadian Heritage Rivers. This national recognition was achieved in 1994 and is based on outstanding river-related recreational and human heritage features/values of national significance. The Canadian Heritage Rivers designation does not have any regulatory or legal restrictions. This report outlines past and ongoing research on bridges in the watershed, which is one component of the designation, and the GRCA process to receive information for the watershed bridge inventory.

REPORT:

A Heritage Working Group was formed in 1995 after the Grand River and its major tributaries were declared Canadian Heritage Rivers. Members are drawn from watershed municipalities, Parks Canada, museums, universities, heritage groups and the GRCA.

Prior to obtaining the Canadian Heritage River designation, an inventory of significant heritage features/values was carried out to demonstrate that the Grand River and its major tributaries were worthy of national recognition. The GRCA maintains and periodically updates the Heritage River Inventory following "A Cultural Framework for Canadian Heritage Rivers" published by the Canadian Heritage Rivers System in 2000. This inventory is an important reference tool for developing the annual and decadal monitoring reports.

The Heritage River Inventory initially included twelve heritage bridges that were identified in the Ontario Heritage Bridge Program (1991). Historic bridges represent one of the main elements contained in the cultural framework. The heritage value of the majority of bridges within the watershed was not assessed at that time.

In 2003, an assessment was undertaken entitled Grand River Heritage Bridge Inventory (Grand Old Bridges). The inventory work was based on secondary sources of information; no primary research was carried out. All watershed municipalities were requested by the GRCA to provide relevant information and comment on the proposed ranking criteria. The consultants considered 99 bridges throughout the watershed, most of them along the main stem of the Grand River. A total of 69 bridges were considered to have heritage significance, supporting the heritage river designation. In some cases, municipalities did not provide the consultant with information. Since the evaluation was based on secondary data sources and not all bridge structures were assessed, information about the bridges is not complete. The Grand River Heritage Bridge Inventory was supplemented by information obtained through a comprehensive inventory of heritage bridges in Waterloo Region undertaken by the Region of Waterloo in 2004 and 2007.

In 2008, GRCA Report No. CW-10-08-81 outlining the benefits of and steps required to undertake an assessment of all heritage bridges in the watershed was presented to the GRCA members. Concurrently, the Heritage Working Group explored opportunities to:

- 1) collaborate with the Ministry of Tourism, Culture and Sport
- increase awareness of the value of heritage bridges
- obtain resources and financial support for a comprehensive update of the Heritage Bridge Inventory

In 2009, GRCA Report No. CW-04-09-32 was prepared, advising that the Heritage Resources Centre at the University of Waterloo was interested in undertaking the additional heritage bridge inventory work. GRCA staff was requested to work with the Heritage Working Group and the Heritage Resources Centre to continue to explore opportunities for external funding.

In 2010, the Heritage Resources Centre submitted an application to the Ministry of Tourism, Culture and Sport through the Creative Communities Prosperity Fund (CCPF) for funding to complete the Grand River Heritage Bridge Inventory. The Heritage Resources Centre was notified that it had been successful in obtaining \$45,000 from the Ministry. The GRCA has provided an additional \$2,000 (from the 2011 budget) and will encourage watershed municipalities to participate in the project.

The project starts in March, 2012 and will be completed in 2013. A report that describes the process used to create this inventory will be part of this project. It is hoped that this report will be useful for municipalities who may want to carry out or update their heritage bridge inventories. The report will also be useful for updating the Heritage River Inventory and supporting the development of the 20-year Heritage River Monitoring Report for the Grand River, due in 2014.

The Ministry of Tourism, Culture and Sport is the lead policy and commenting agency for heritage. Through the Environmental Assessment Act, GRCA staff encourage the proponent to conduct a heritage assessment for bridge projects. Staff request copies of heritage assessments and/or photos for the Heritage River Inventory. In some cases an Environmental Assessment may not be required. In these circumstances, during the GRCA permit approval process, staff request photos of the bridge for the purpose of supplementing the information in the bridge inventory. Staff include general information regarding bridges in the permit reports to the GRCA for information. The Canadian Heritage River designation does not have any regulatory or legal restrictions.

FINANCIAL IMPLICATIONS:

The Grand River Conservation Authority contributed \$2,000 to this project from the 2011 budget.

OTHER DEPARTMENT CONSIDERATIONS:

The Coordinator of Policy Planning and Partnerships will participate on a project Steering Committee. Resource Planning staff provide advice and request general information for the bridge inventory through the Environmental Assessment and permit process.
